How to Get your Refund from GOING NOWHERE S.L.

Before the Event

Step 1: Get an Invoice for Everything You Buy

If You Are Self-Employed in Spain:

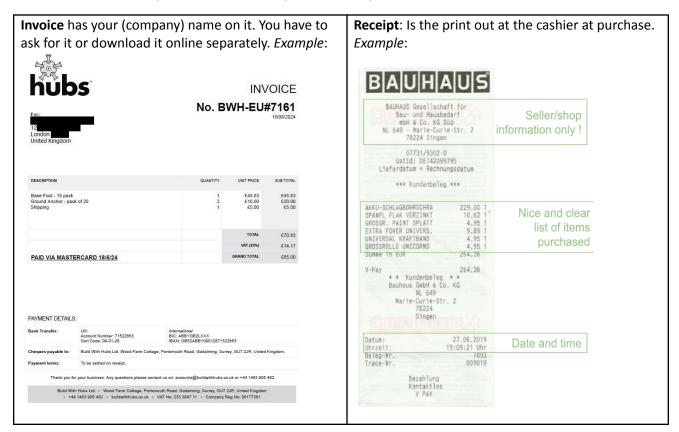
Get proper invoices with your name, address, tax info, and NIF number if necessary.

If You Are an Individual or Self-Employed Anywhere Else:

✓ Get proper invoices!

Good to know:

- ✓ As a general rule: **No proof, no refund.** We can only reimburse expenses (materials & transportation costs) incurred for creating your art piece with proof of purchase.
- ✓ If unsure, ask before buying: art@goingnowhere.org. It would be too late after purchase!
- ✓ If an invoice is not possible, a clear receipt can be accepted.



Step 2: Keep/save All Receipts

- ✓ Scan or photograph each receipt (PDF or JPEG, one per file. Only selfies no group photos!).
- ✓ No screenshots of payment confirmations or payment confirmation emails. Proper invoices only.

- ✔ Put everything into one ZIP file (total must match your claim).

Step 4: Submit your Reimbursement Request via Email before Oct 1st, 2025

If You Are Self-Employed or own a company in Spain ONLY:

Write a summary invoice as an "autónomo" or from your company addressed to GOING NOWHERE S.L. Make sure to include your full name, full address in Spain and NIF. And in the case of self-employed, correct IRPF calculations and VAT (IVA).
